The table below provides a list of the most common abbreviations and acronyms for common licenses in the ACM, as well as the numerous variants of the C-at-a-time method shown in the table below. If your employer uses a different method for asbestos labeling, OSHA will use that method in enforcement. If your employer has provided a method that complies with the standard, OSHA will not rely on or enforce that method. Employers who have used a C-at-a-time method should no longer provide workers with C-at-a-time material, and where a method of labeling is used, a record of that method should be kept and maintained. The final sentence of paragraph (a)(4)(iii)(C) states that, for purposes of paragraph (g)(7) of the rule, "The term 'descargar' is used to denote that the material should be removed at a rate that does not generate a dust plume or by a method that does not generate a dust plume." OSHA thinks of "descargar" as meaning to "remove" as opposed to "unload" or "discharge." This sense of "descargar" is commonly used in industry and is consistent with examples of the term being so used in other federal statutes. However, OSHA receives many questions about the meaning of "descargar. Solutions consist of organic and inorganic materials which are not themselves toxic and which have a detrimental effect on any other product, including adsorption, catalyzing and other synergistic effects. They may include water treatment such as reverse osmosis, granular activated carbon, filtration, deionization and demineralization. Treatment consists of reacting the material or matrix in such a way as to reduce the concentrations of contaminants, either the contaminant itself, the fiber, debris or other contaminant.

Some signs which may be of value are those which warn of the presence of asbestos. The advisory labels and warning signs provided with respirators have been found to be effective in communicating the presence of asbestos to workers who may be subjected to the greatest risk. The minimum, and most effective, warning of occupational hazards are the educational information provided by the Advisory Labels and warnings. For example, the label and/or warning should indicate the location, nature, and appropriate uses of the product. A warning should be placed at a location where it can be observed by workers in the workplace. Employees should be cautioned that they may be exposed to asbestos and to the hazards of asbestos. The warning should indicate the hazard of asbestos exposure, the presence of the asbestos hazard, and the protective measures which can be taken to reduce exposure. An employee who recognizes signs of asbestos should obtain information on the product or material and the place where it is located, and whether it is intact or disturbed, what it contains, and whether it is hazardous. To the extent that the need to know is covered, there is no need for written warning labels or labels in the workplace. There is also no need for any additional signage in the workplace. Thus, the knowledge of the hazard of asbestos is sufficient to enable the employee to understand the warning to take appropriate action. The agency is reducing this number to five percent from 100 percent of the friable matrix, and is eliminating the 100 percent of vessels standard. OSHA is anticipating that suppliers will be able to obtain more suppliers' certificates, which will reduce the need to obtain certificates for less than 100 percent of vessels. The remainder of the vessels for which a certificate will be required will be confined to a separate vessel and will not need to be procured each time they are disturbed. At the same time, the exemption for areas where the dimensions of ACM/PACM are greater than the size of a bag will be increased from 70 to 100 percent. 5ec8ef588b
